## **SPA Athlete Hall of Fame Induction - Marnel Spencer**

Since joining the Saskatchewan Powerlifting Association in 2015, Marnel has exemplified the spirit of determination and excellence in the sport of powerlifting. Starting her journey as a Masters 2 athlete she has proven that age is merely a number, defying stereotypes and inspiring lifters of all ages to pursue their goals.

Over the years, Marnel has not only made a name for herself at the provincial level but has also achieved remarkable success on the national and international stages. Most notably, winning the Masters 3 World Champion title at Masters Equipped World Championships in 2022, and claiming the Equipped Squat and Total World Records at NAPFs in August 2024.

She has represented Saskatchewan at CPU Nationals 6 times, being crowned the National Champion at each. She has also represented Canada at 4 international meets including:

- 1st place at 2015 NAPF Championships (M2)
- 4th place at 2018 Classic World Championships (M2)
- World Champion at the 2022 Masters Equipped World Championships (M3)
- 1st place at 2024 NAPF Championships (M3)

Marnel has previously broken and currently holds numerous records across multiple age and weight classes, at all levels of competition. The majority of her currently held records were set competing as a Masters 3 lifter.

Dear SPA Membership,

Firstly, I would like to thank the current board for their continued invested time and energy to support powerlifting in Saskatchewan. These are volunteer roles, and it is important to acknowledge their contributions in helping the sport grow and flourish. Our technical chair, Tanner LePage, will be ending his term, and we wish him all the best. Additionally, this will also be my last report as President. As the upcoming board comes into place, I am confident that their strong commitment will help the association and its members continue to thrive.

The board and association have continued to work hard behind the scenes. This year, the following policies were updated as per CPU direction: Complaints, Discipline and Appeals. We also have created a new Inclusion policy, which been modernized to reflect discrimination and harassment. After a decade from our last proposal, the board was able to submit an application to Sask Sport; we eagerly await the results. Lastly, movement on our strategic plan continues. The SPA enters into the last year of the plan, with only a few remaining goals to achieve. We have also been able to:

- Increase our membership numbers to 189 members. Notably, our Special Olympics membership has increased to 18 members from 4. Our youth membership remains active with a slight decrease from 10 members to 6;
- Maintain club association (9 registered clubs for 2023-2024);
- Continue to provide and send out certificates for members who proudly have broken provincial records;
- Implement a new records tracking system;
- Welcome one new national referee (Heidi Fowler) and three new provincial referees (Kate Douglas, Franki Nault, and Mike Hart) this year;
- Obtain a fiscal surplus, which will allow the association to invest back into the membership;
- Highlight numerous athletes who have gone to National Championships and International Competitions;
- Update our agreement and clarify processes with Special Olympics Saskatchewan; and,
- Proudly support 2024 Western Championships.

The SPA sent a small team of 19 people to the 2024 CPU National Championships this year in Summerside, Prince Edward Island. I would like to thank the following sponsors again for their support: Gold Sponsor - Strength Screen Printing; Silver Sponsors - Foundation Fitness, Inner Strength Products; Bronze Sponsors: Valkyrie, Olympia In Depth. We also send congratulations to our athletes who were able to achieve personal bests and breaking records at all levels while representing both Saskatchewan and Canada on the international stage at North American Powerlifting Championships, Commonwealth Championships, and World Championships. Lastly, we also acknowledge and congratulate Ryan Stinn for receiving the highest honor in Canadian powerlifting – the Bill Jamison Award.

I would like to close my report by extending gratitude to SPA. My tenureship in this role began in the pandemic, which was no easy task. It was a steep learning curve finding our way through balancing restrictions and return to sport, into a rebuilding phase while navigating important inclusion issues within the Canadian powerlifting climate. The support and hard work from the board has translated into a much stronger foundation for SPA to move forward with, and I wish the association all the best.

#### 1) Nature of operations

The Saskatchewan Powerlifting Association (SPA) is a non-profit provincial member-based organization and was incorporated in 2009 under *The Non-profit Corporations Act of Saskatchewan, 1995.* The Association exists to serve as a provincial affiliate to the Canadian Powerlifting Union, and to act as a governing body for related activities in the province of Saskatchewan.

#### 2) Summary of significant accounting policies

These financial statements have been prepared in accordance with the Canadian Accounting Standards for Not-for-profit Organizations (ANSPO). These financial statements reflect the following accounting policies:

#### **Financial Instruments**

Financial assets and liabilities are recorded in the statement of financial position at the time when the Association becomes party to the contractual provisions of the financial instrument. Financial assets and liabilities are initially measured at fair value. Financial assets and liabilities are subsequently measured at amortized cost.

Financial instruments contained in these financial statements include cash and accounts payable.

#### Medals & awards inventory

Inventory is valued at the lower of cost and net realizable value. Cost is determined using an average costing method.

#### Tangible capital assets

Purchased tangible capital assets are valued at the cost at acquisition, in addition to all directly attributable costs to the acquisition of the asset. Contributed capital assets are valued at the fair value at time of contribution, as well as all directly attributable costs of acquisition. In the event that fair value of a contributed asset cannot be determined, the asset will be recorded at a nominal value.

Tangible capital assets, purchased or contributed, are expensed in the period in which they occur. The Association owns assorted powerlifting equipment used in the facilitating of powerlifting events in the province of Saskatchewan.

#### Revenue

The Association follows the deferral method of accounting for contributions.

- SPA Membership fees, club membership fees, and other various fees are recognized in revenues in the current period in which they occur.
- Clothing sale revenue, as well as medal & award sales are recognized in the period in which the
  products are delivered to customers, or when acting as an agent for the transaction, when funds
  are received.
- Sales of tangible capital assets are recognized in the period in which the sale occurs, and ownership is transferred.

 Drug testing fees are to be reported net of expenses, as the Association is acting in an agency capacity.

## 3) Prepaid expenses

Prepaid expenses relate to insurance premiums paid in the year that have not yet been recognized as an expense. Premiums paid relate to a policy covering the year ending April 28<sup>th</sup>, 2025. The remaining policy asset will be amortized to the Statement of Operations subsequent the current fiscal year end.

## 4) Medal & Awards Inventory

Medals and Awards inventory consists of items purchased for use at the Saskatchewan Provincial Championships. Inventory is held on the Statement of Financial Position until such time as it is distributed. The balance consists of:
